City of Aberdeen to hold ADA public workshop June 2

City intends to develop plan for curb ramps, sidewalks, driveways, paved shared-use paths and pedestrian street crossings

If you want to take a survey: The city of Aberdeen is encouraging residents to participate in a 12-question online survey to help identify physical barriers in the city’s public right-of-way, or other barriers to city services, programs, and activities, which will be open until June 15. The survey can be accessed by scanning the QR code.

The city of Aberdeen is developing an Americans with Disabilities Act (ADA) Self-Evaluation and Transition Plan for public right-of-way focusing on curb ramps, sidewalks, driveways, paved shared-use paths and pedestrian street crossings within city limits.

Aberdeen City Engineer Nick Bird announced the initiative at the May 14 city council meeting.

According to city officials, “The city of Aberdeen is committed to providing equal access to its public right-of-way facilities for all citizens including those with disabilities.”

Bird said via email, “We want to make sure the community is aware of our efforts. Feedback is important as it will help us prioritize our improvements or make us aware of a need on the off chance we missed it during our review.”

Recently, an ADA complaint prompted the city to take action on damaged sidewalks on a section of Market Street. That work, from I Street to L Street, began the week of May 10 and addresses ADA accessibility deficiencies throughout the corridor, bringing sidewalks up to current standards for safe and inclusive access.

The ADA public workshop is set for Monday, June 2, from 6 to 7 p.m. at the Rotary Log Pavilion in Aberdeen. If you cannot attend in person, there is an online option, which can be found at <https://www.aberdeenwa.gov/607/ADA-Transition-plan>

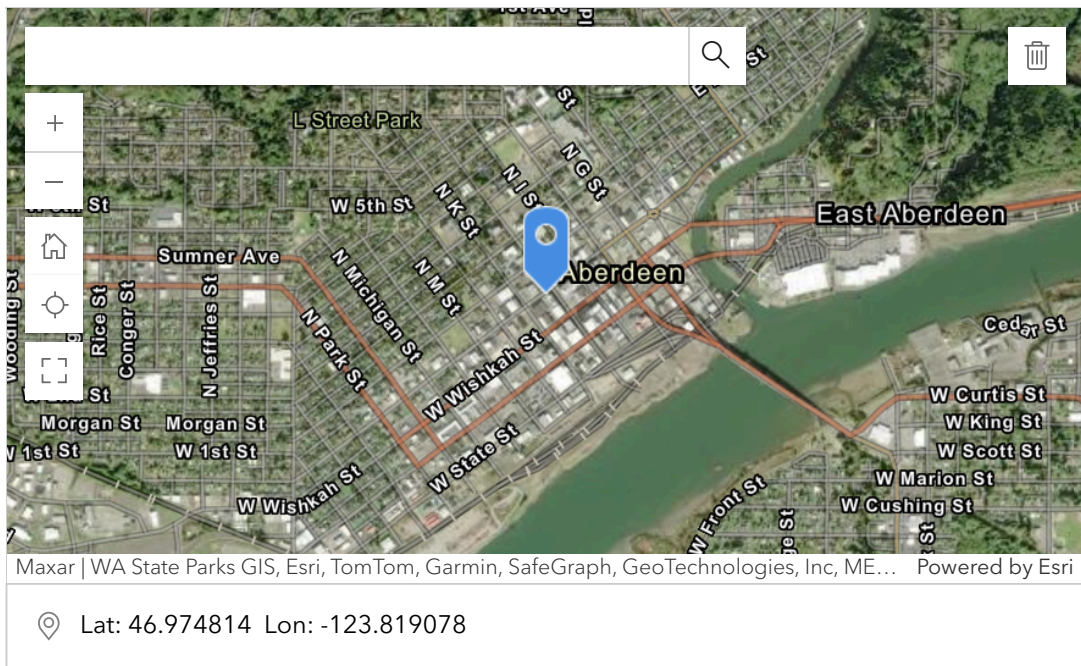

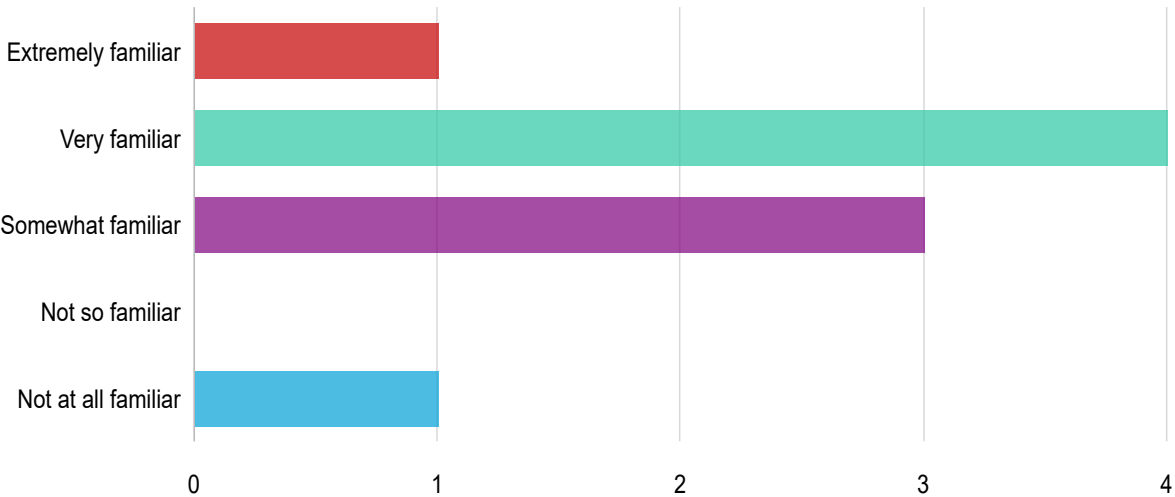

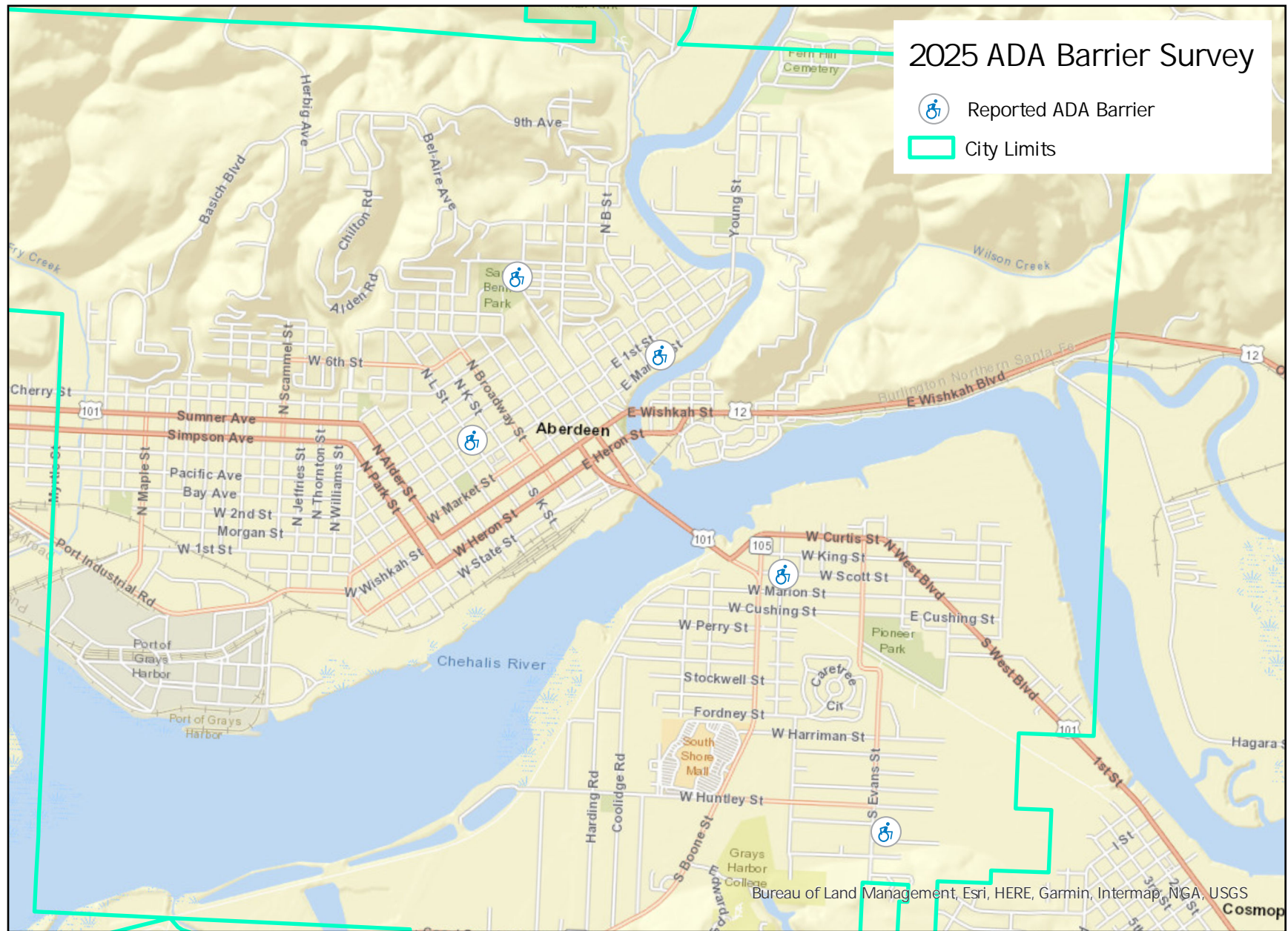

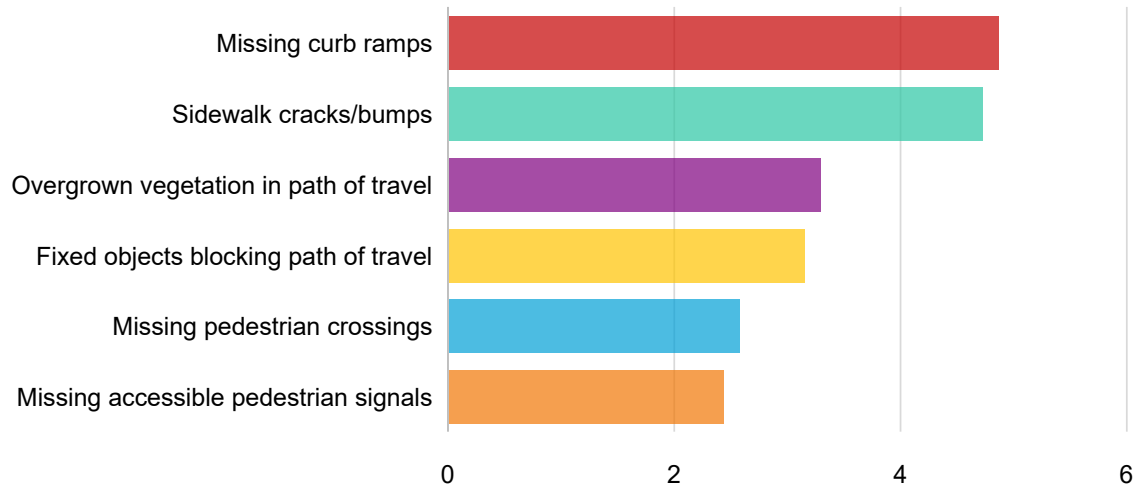

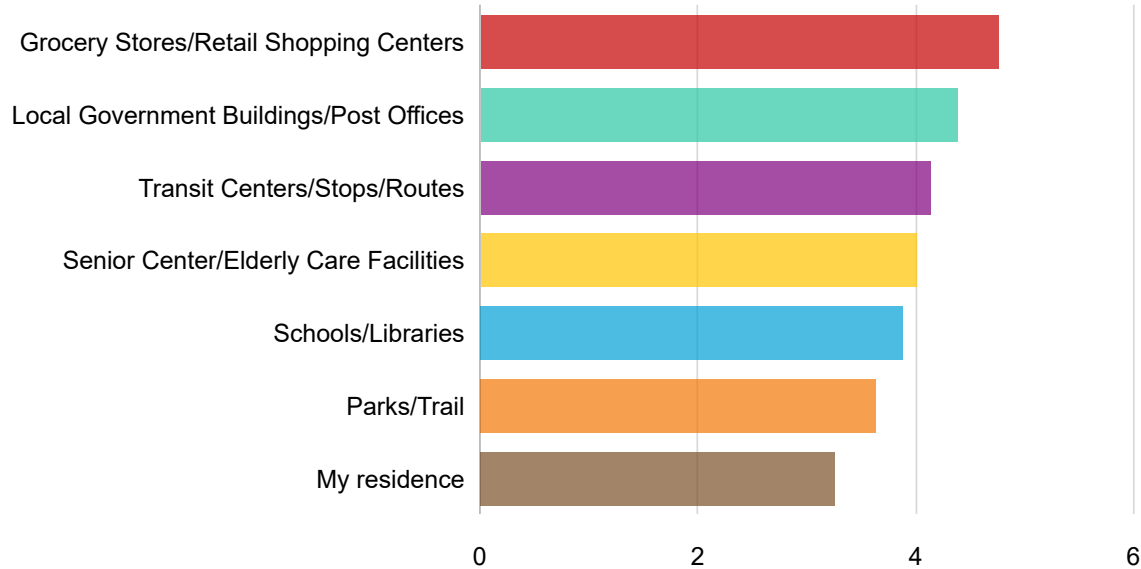

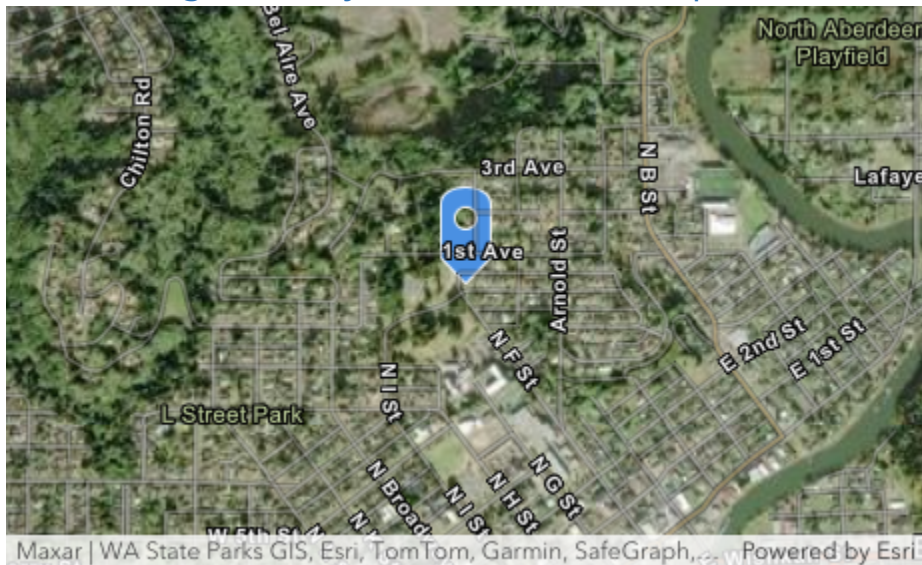

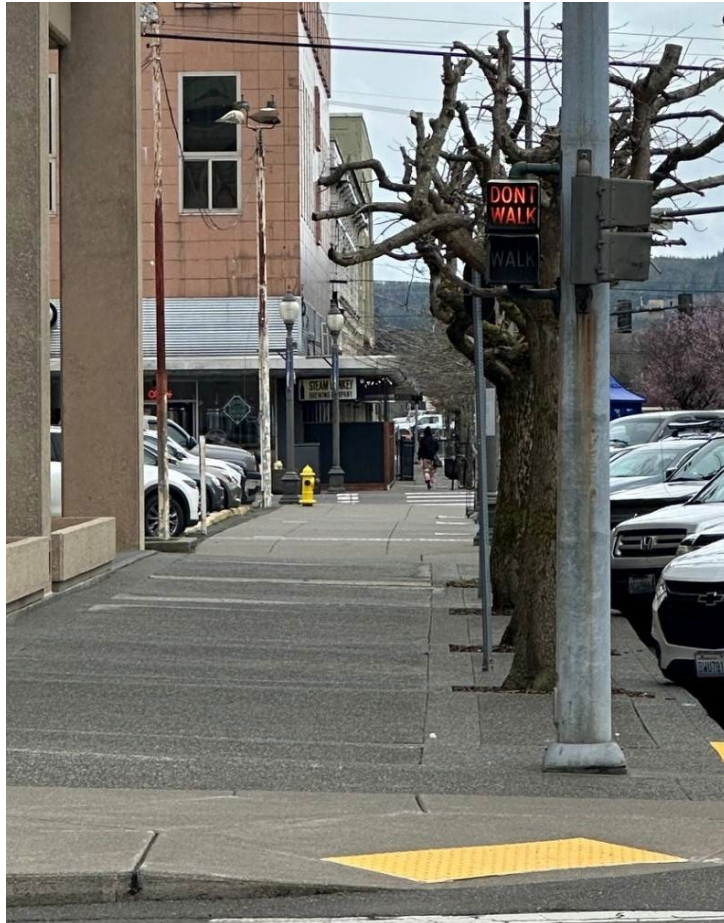

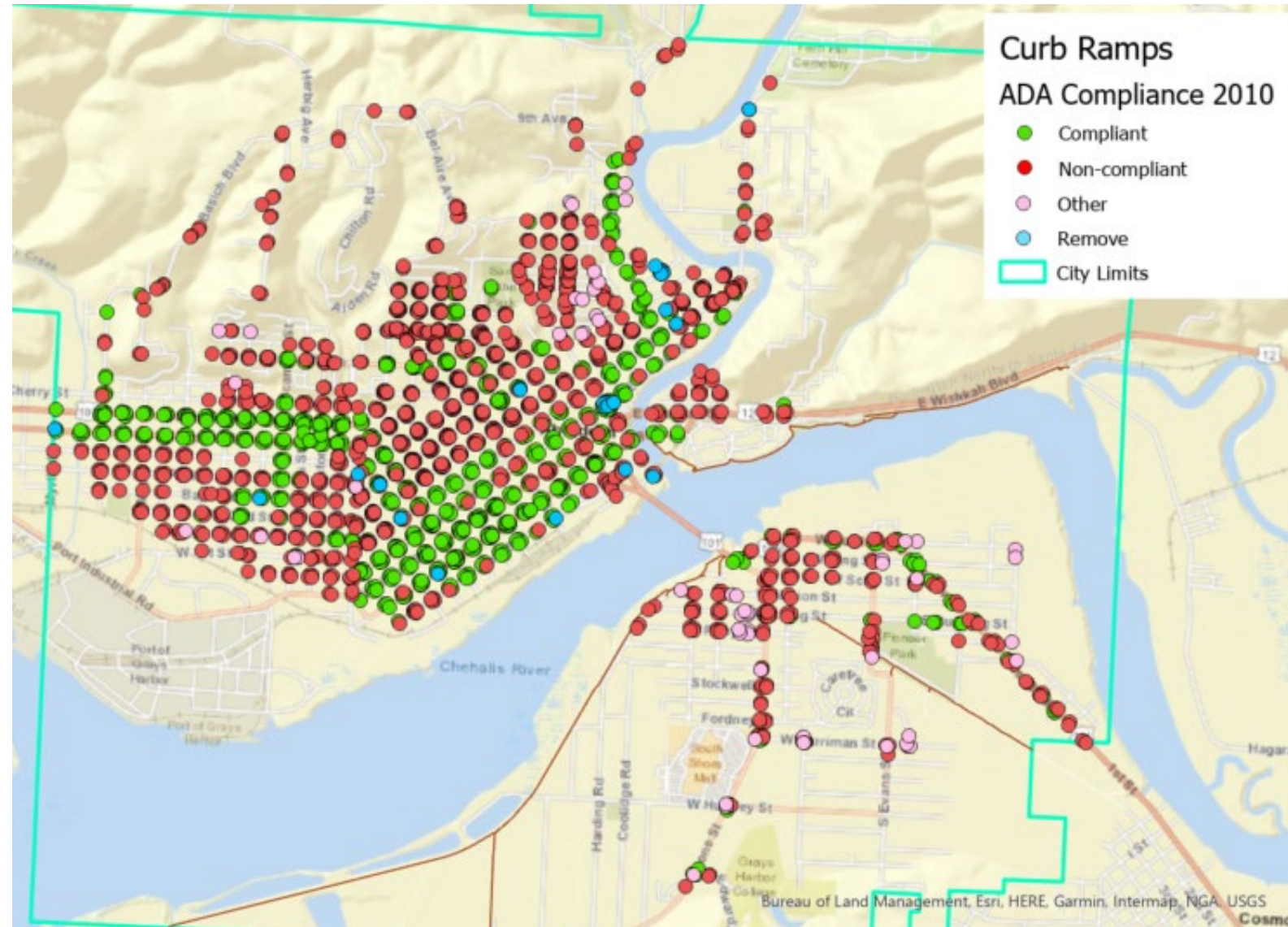

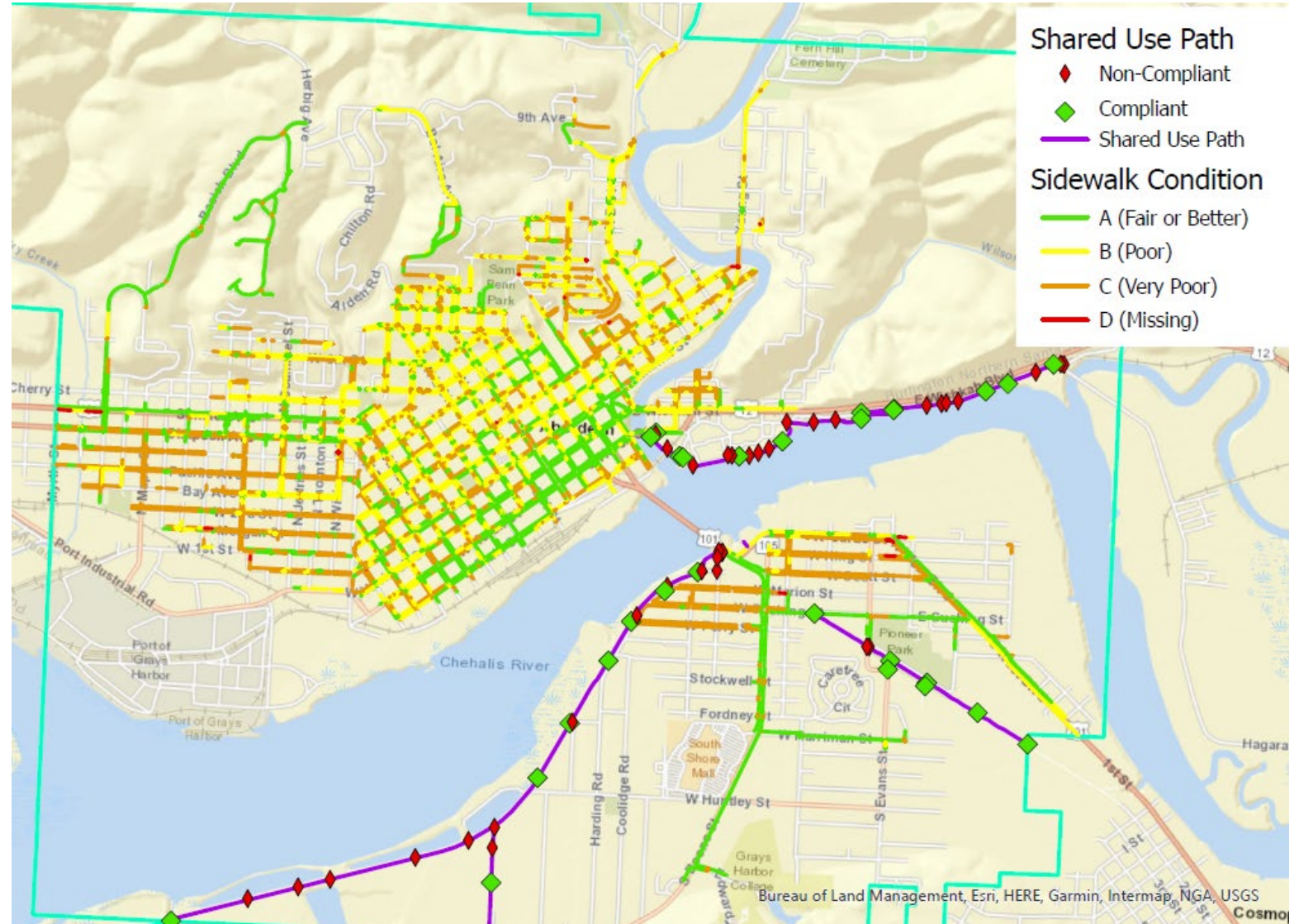

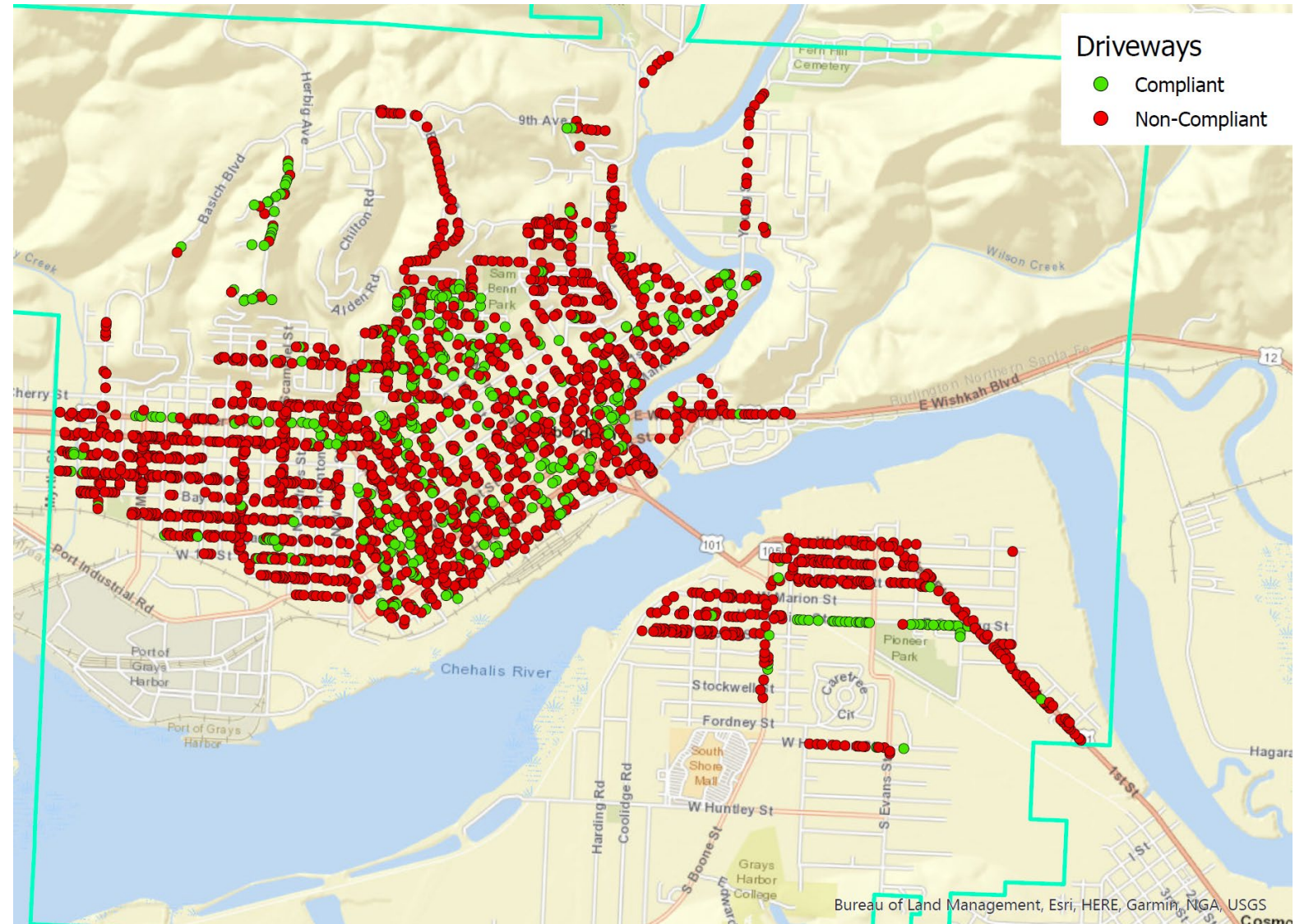

I support the changes to ramps and curbs, etc for ADA. However the City's recent addition of white striping with upright barrier stanchions at intersections have decreased the amount of space in lanes for vehicles. I drive a 2005 Dodge 2500 diesel pickup. It is a standard stock full-size - no big tires, etc. When approaching the intersection at North F and 1st Street there is just enough room for 2 trucks meeting each other. It appears someone has already hit one of the stand up stanchions.

2 weeks ago I was at said intersection going south on F Street with a full size pickup in front of me at the stop sign. An ambulance came heading east on First Street and turning left on North F. They barely made it by our pickups. Next came the Engine truck. The pickup in front of me pulled partway around the corner to the right and stopped. The Engine truck tried to navigate the turn to the left but had to stop while I backed up to let them through. I was able to backup after the car in behind of me also backed up.

This is a huge safety hazard as well as a barrier to the fire trucks that need to get to their destination in the event of a fire. Are they supposed to smash through the upright stanchions or smash through vehicles stopped at the intersection? I believe the stanchions pose an incredible financial risk to the City.

In addition because the stanchions are placed so far out at several intersections you have to turn into the oncoming turn lane to make it around the corner. This is especially true if you are pulling any type of trailer. If there is a vehicle sitting in the turn lane you are forced to stop in the intersection to let them go so you can complete your turn without hitting a stanchion and damaging your vehicle.

I can't believe I am the only citizen who has experienced difficulty with the placement of the stanchions. I have no problem with making corners safe for pedestrians but I believe in this instance someone went overboard. Perhaps the stanchions could be moved back to serve both pedestrians and vehicles.

Thank you for taking my comments under advisement. I appreciate the opportunity.

I appreciate all the time the city took to solicit feedback. The plan looks well thought out and intentional. Yes, all 58 pages of it :)

From the inventory to the budget, to the next five years of fixes - I'm happy to see this quality of work being done. I really liked seeing the East Aberdeen Waterfront Trail listed as an area that's specifically highlighted as something to fix; that park is in some disarray and some attention would be well worth it. I really liked seeing the plan to address the two intersections on Broadway w/ updated crosswalk buttons. Finally, the missing sidewalks on Simpson were highlighted as another area for attention, and I agree - they could use some pavement / cement.

Overall - this looks great. Thank you for the attention to detail, keep up the good work!

Concerns:

- 1) litigation / legal risk: Does the city council need to update the AMC? Maybe not, but I worry that someone might sue the city, claiming that the out of date AMC shows negligence. Might be good to get them to look at the curb ramp justifications, driveway slopes, sidewalk maintenance duty, and add a technical infeasibility study (as required by the ADA Plan) to the public works policy.
- 2) firetrucks / fire department & emergency vehicle access: May require coordination with fire dept, you're all probably already on that. But getting the fire dept to sign off on the ADA plan might help head off trouble there. For what it's worth, I'd love to see some city guidance that we look to REDUCE the size of the firetrucks. They're expensive, they require expensive street modifications, and it's unnecessary (fire events vs expense / overhead for trucks). I know that's not the engineering dept's authority, but sheesh. Enough is enough with the giant firetrucks.



- 3) I think RCW 35.68 suggests cities adopt an ordinance that makes sidewalks the responsibility of the nearest landowner. I guess that makes sense, but seems like it'd be really unpopular, hard to enforce, and lead to super sloppy/inconsistent construction. I know it's not included, and I hope it stays omitted.
- 4) grievance form: it seems mostly about physical barriers, while one of the appendices (C I think?) listed digital accessibility. Might put in some language in the form so that same form could be used for digital accessibility grievances as well.

Great work! Keep it up, y'all are doing great.

### **Tsunami Evacuation Route Accessibility**

South Aberdeen is home to thousands of residents, many of whom must evacuate to one of three designated tsunami assembly areas. We live one house away from one of these routes, and can confirm that there is *zero* pedestrian access outside of walking directly in the roadway.

The evacuation path includes a steep incline, which poses serious difficulty for pedestrians — especially during an emergency. This challenge is worsened during school hours, when evacuating students from Stevens Elementary and Miller Junior High will create dense foot traffic.

In our household, for example, our go-bag includes a handled cart and a trained service animal. This isn't an anecdote — it's a direct illustration of how ADA-impacted residents will struggle during evacuation conditions. Navigating that slope with a cart and service animal, while surrounded by cars on a narrow road, is dangerously unrealistic. We strongly encourage on-site review of these routes with ADA compliance in mind *during an actual ShakeOut drill* for firsthand insight.

---

### **Grays Harbor Transit Access**

Public transportation only works if residents can safely *reach it*. Much of South Aberdeen lacks sidewalks or safe shoulders — forcing many, including transit users, to walk in active roadways. We urge the City to coordinate with Grays Harbor Transit and County services to ensure safe, ADA-compliant pedestrian access to existing transit stops in underserved areas.

---

## **Unmarked Streets, Lack of Shoulder, and Speeding**

Many side streets in South Aberdeen are narrow, shoulderless, and lack lane markings. We accepted that reality when moving here — but did not expect frequent speeding on these residential roads.

The absence of any visual lane guidance leaves both drivers and pedestrians guessing — and that's dangerous, especially for children walking to schools, families heading to parks or trails, or disabled residents attempting any travel at all.

We are not demanding immediate sidewalks everywhere. But even basic measures like lane lines, shoulder definitions, or painted pedestrian zones could improve safety dramatically. Without these, even standing off to the side becomes difficult — loose gravel, vegetation, and sloped shoulders make it nearly impossible.

As with the tsunami route mentioned above, we urge City staff to participate in school ShakeOut drills to see how these narrow roads perform under emergency evacuation stress.
