



# COMMUNITY SERVICE

## Aberdeen Municipal Court

If you have been ordered to perform community service or would like to perform community service to help pay off court-ordered fines, you must perform the community service with one of the court-approved programs below unless a written order of the court allows for alternative community service. All community service hours must be verified by an agency supervisor on the Community Service Verification Form located on the back of this form. All hours will subsequently be verified by the court.

Community service hours must begin within 30 days and be completed within 6 months from the date the fine or community service hours were ordered unless otherwise specified by the court. If the Community Service Verification Form is not filed with the court monthly, the balance owed will be sent to collections. If you were ordered to perform community service, you may be summoned for a revocation hearing for failing to comply with a court order. If you wish to pay your fine in full or set up a payment plan, please contact the court. You may perform community service hours in combination with fine payments. Your community service hours are credited at \$17 per hour.
