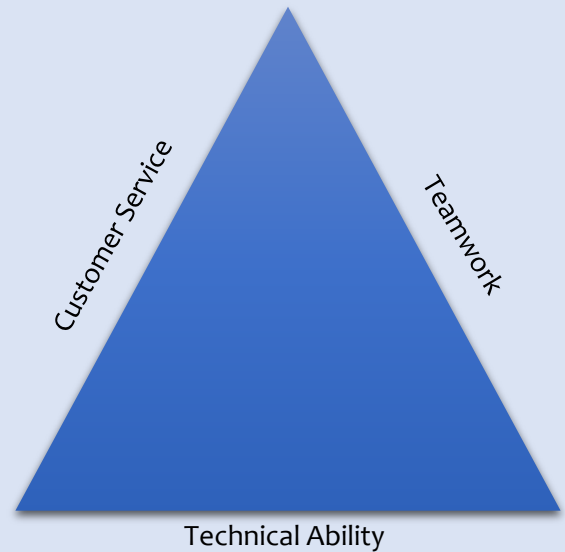

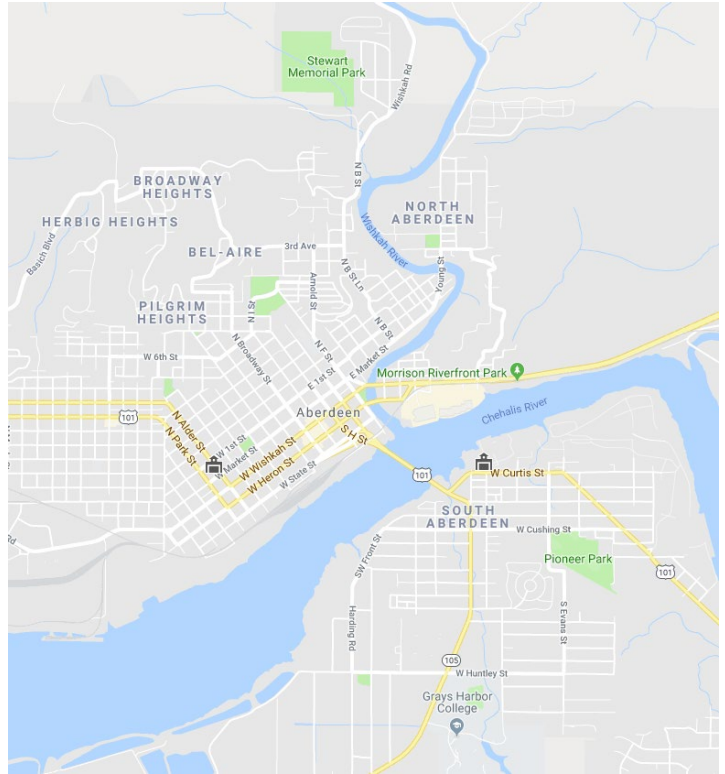


# DEPARTMENT OVERVIEW

The Aberdeen Fire Department is a career response agency providing a full complement of fire suppression, emergency medical services and fire and life safety education. Comprised of 35 uniformed men and women and 2 full-time civilians, the Aberdeen Fire Department is the largest fire department in Grays Harbor County. The department operates out of 2 strategically located fire stations to meet the emergency service needs of the residents, businesses, and visitors to Aberdeen.

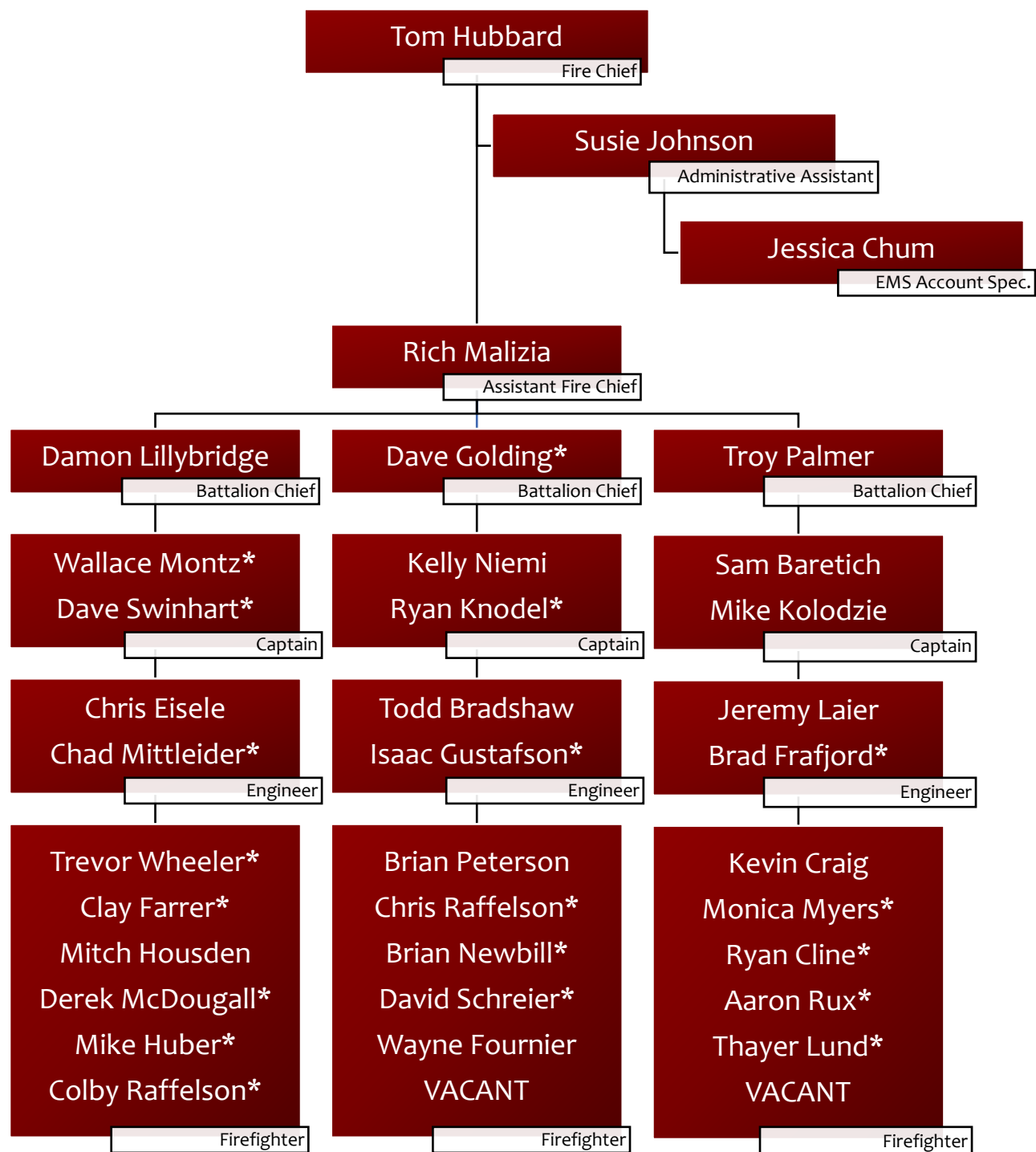

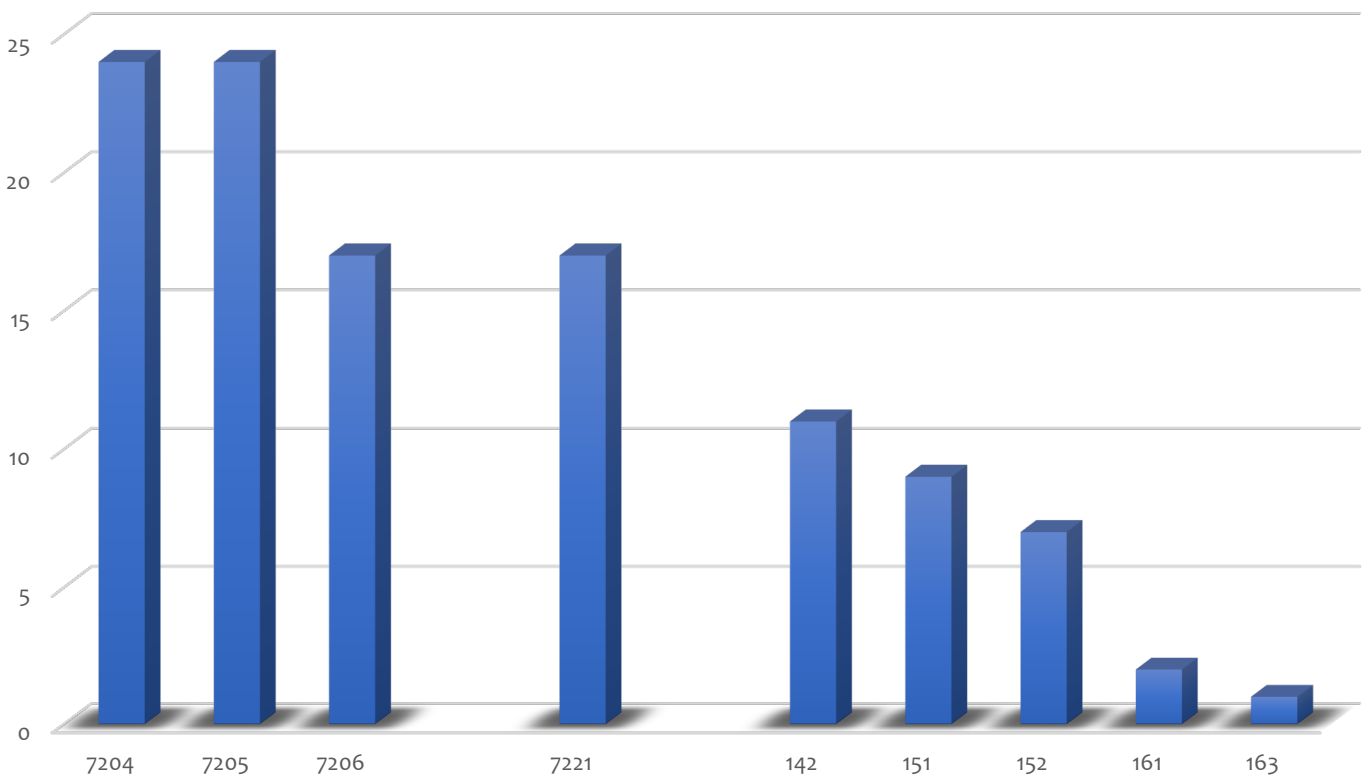

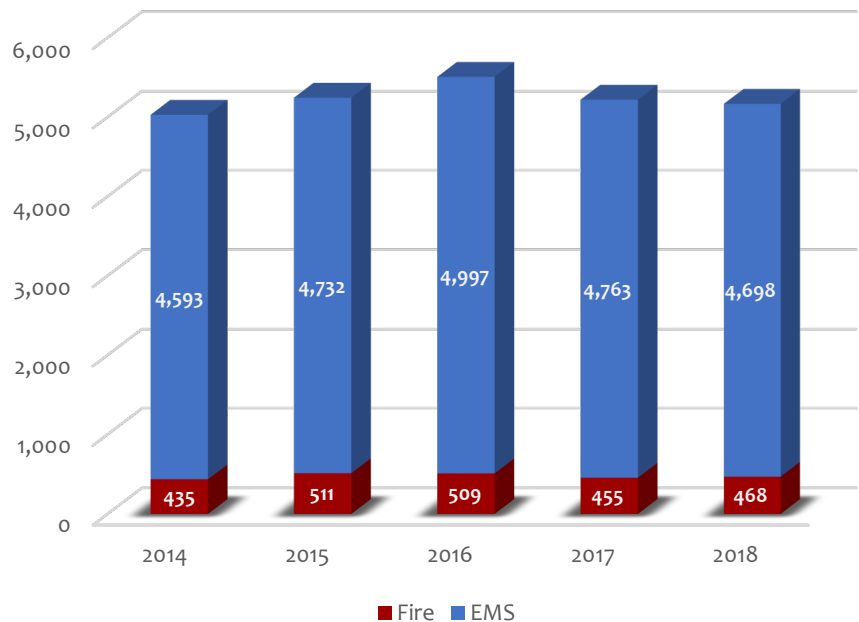

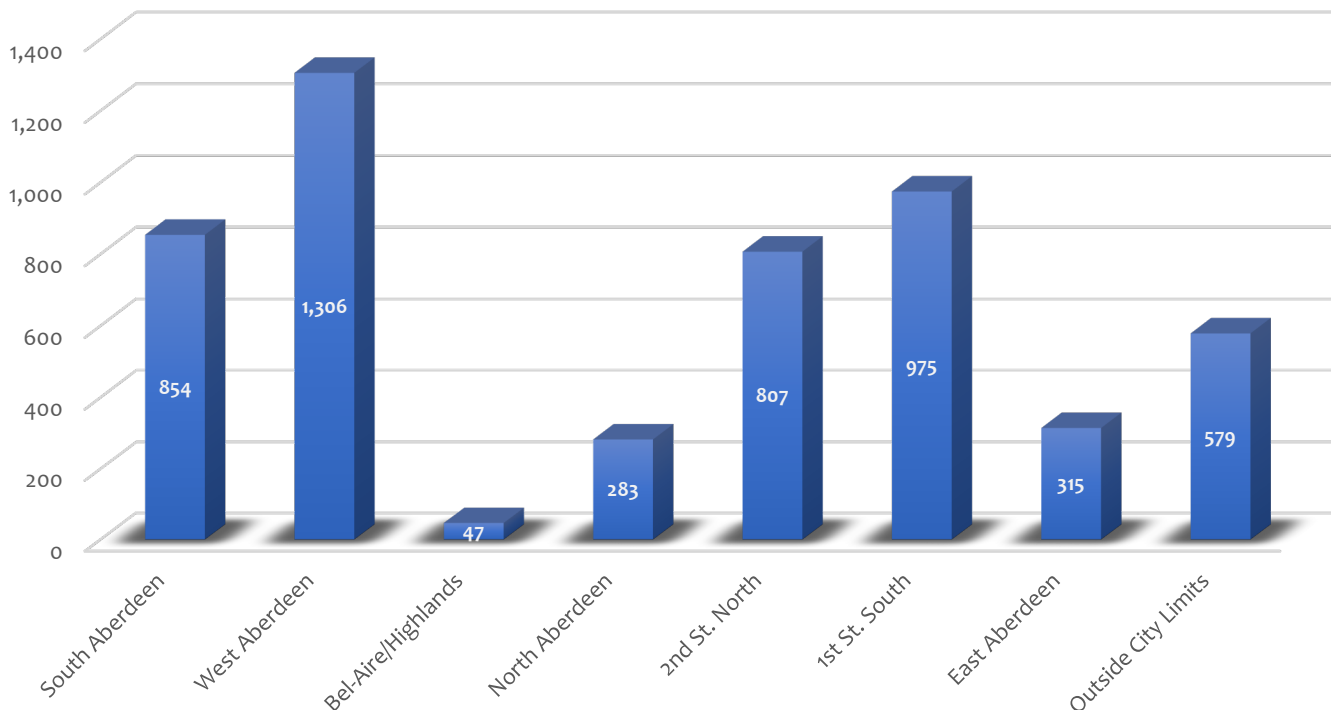
TOTAL INCIDENTS: 2014-2018

TOTAL INCIDENTS BY ZONE: 2018

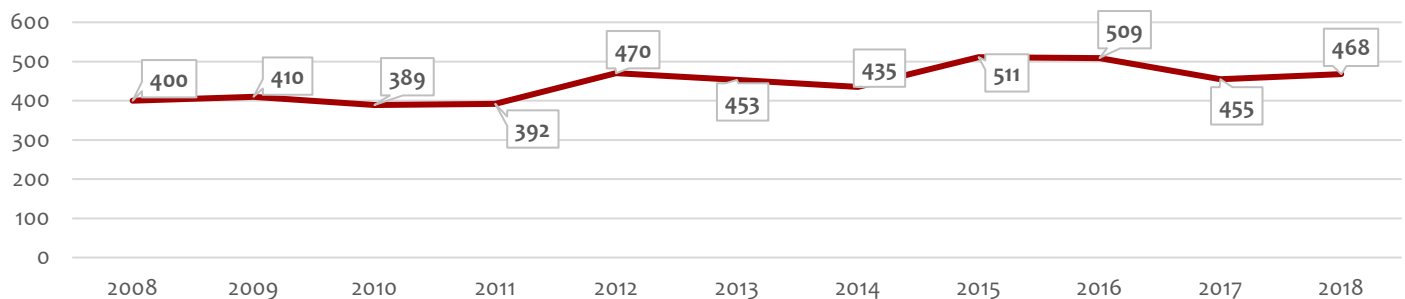


# FIRE OPERATIONS



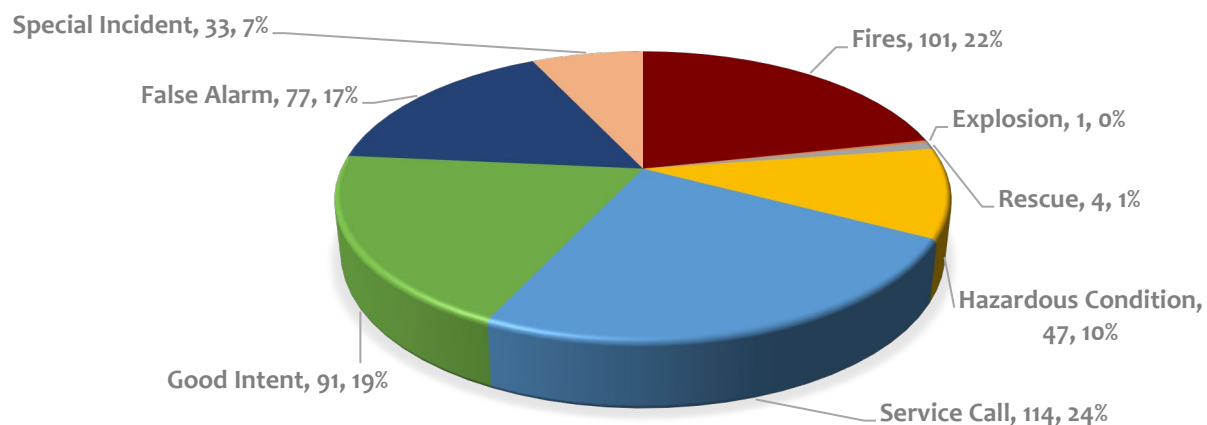
The Aberdeen Fire Department is responsible for providing fire suppression services to the citizens of the City of Aberdeen. We also provide these services to contracted areas of Grays Harbor Fire District 10, Stafford Creek Corrections Center and the Bigelow Drive area. The Department also provides Automatic response for structure fires with the Hoquiam Fire Department as well as responses for requests for mutual aid. In 2018, the Aberdeen Fire Department responded to 468 calls for service related to fire suppression. The graph below illustrates the fire response call volume over the past ten years.

**FIRE CALL VOLUME: 2008-2018**



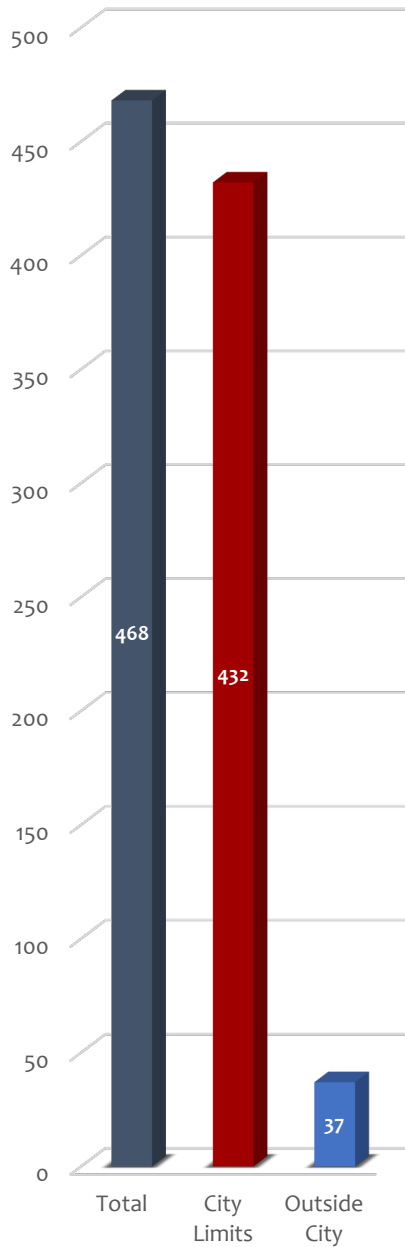
The overall EMS call volume has increased 17% over the past 10 years. There was an increase in the fire call volume from 2017 by 13 incidents. This results in an increase of 2.9% over last year.

**FIRE RESPONSE BY TYPE: 2018**

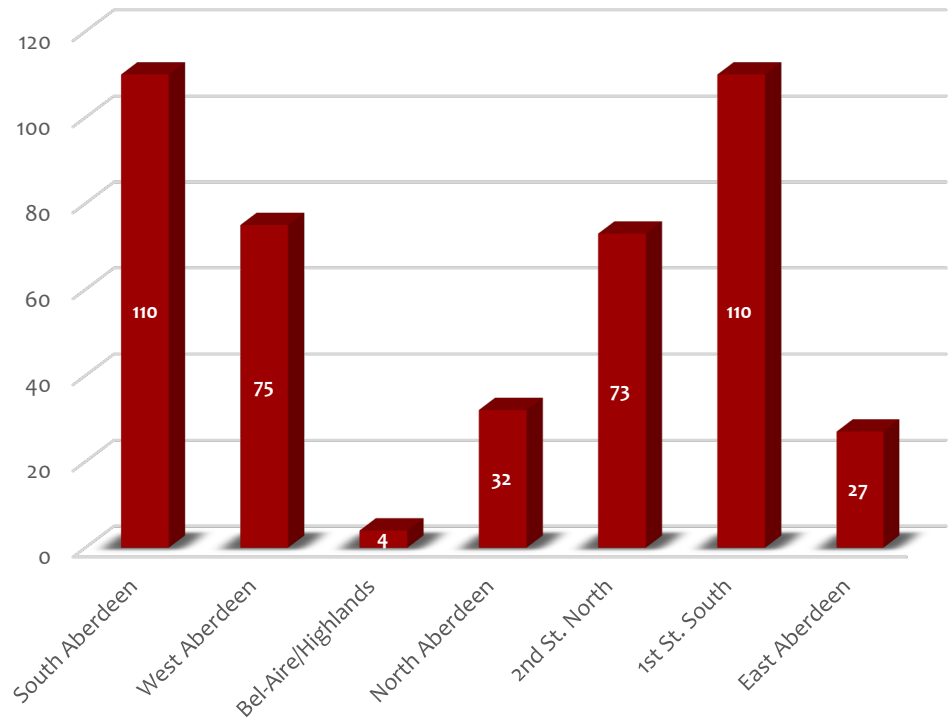




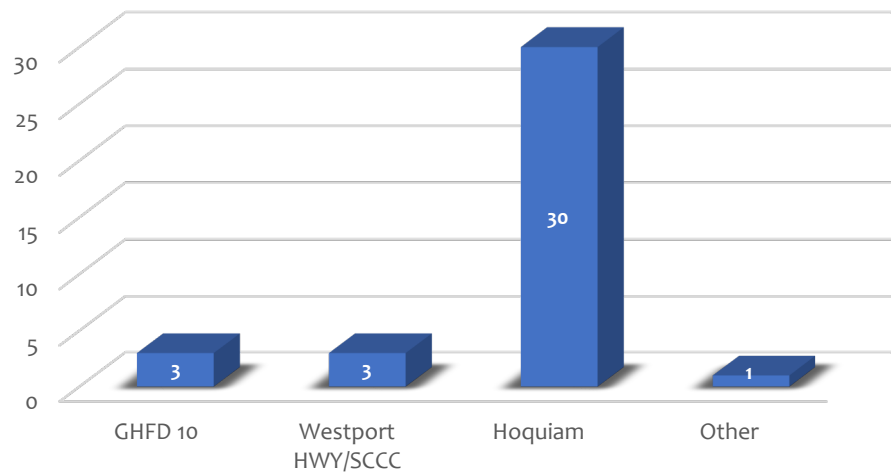

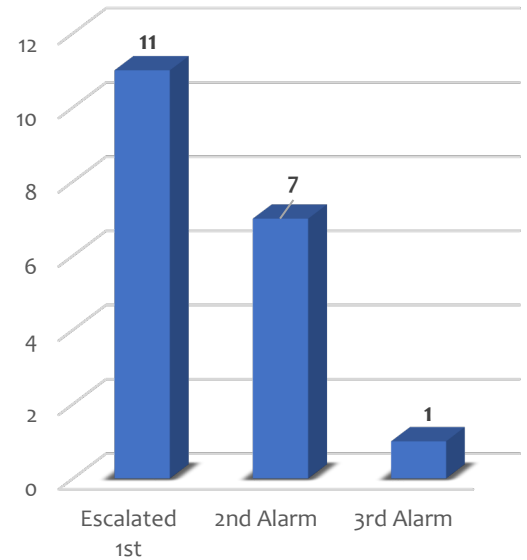

# SIGNIFICANT INCIDENTS



**April 2, 2018**

**Structure Fire, 304 W. 10<sup>th</sup> St.**

A second alarm structure fire with an automatic response from the Hoquiam Fire Department, with the addition of mutual aid from Grays Harbor Fire District 2 and the Cosmopolis Fire Department resulting in \$250,000.00 in losses to the structure and its contents.

**May 16, 2018**

**Pedestrian versus Train Accident, 400 S. Michigan St.**

A patient was struck by a moving train while attempting to cross the tracks resulting in a double amputation of both legs. Quick action by officers of the Aberdeen Police Department helped to control bleeding prior to fire department arrival. The patient was transported to Grays Harbor Community Hospital and then flown to Harborview for advanced trauma care



**June 9, 2018**

**Commercial Structure Fire, 117 E. 3<sup>rd</sup> St.**

A multi-agency response for a commercial structure fire at the Aberdeen Museum of History. The building was a total loss, although many of the artifacts have been able to be restored.

**July 6, 2018**

**Fatality Structure Fire, 410 N. Alder St.**

A second alarm fire with an automatic response from Hoquiam Fire Department as well as mutual aid from Grays Harbor Fire District 2. Upon arrival of initial units, the structure was fully engulfed. The occupant of this structure was found to be deceased inside.



**August 20, 2018**

**Commercial Structure Fire, 3012 Simpson Ave., Hoquiam**

Automatic aid with the Hoquiam Fire Department to Harbor Saw and Supply. The Aberdeen Fire Department provided apparatus and manpower to this escalated alarm commercial structure fire.

**October 18, 2018**

**Fatality Structure Fire, 617 E. 2<sup>nd</sup> St.**

A second alarm fire with an automatic response provided by the Hoquiam Fire Department. During suppression efforts crews located an occupant who was unable to escape and who died in this fire.

On the morning of Saturday, June 9, 2018 at 9:28 AM the Aberdeen Fire Department was dispatched to a commercial fire alarm at the Aberdeen Museum of History located at 117 East Third Street. While responding, the on-duty Battalion Chief noted a large column of smoke and called for a second alarm. Upon arrival on-scene the alarm was quickly escalated to a third alarm with the addition of requests for aeriels from neighboring fire agencies.

Crews initially gained entry into the structure and attempted an offensive fire attack. Due to the amount of fire, this attempt was not sustainable and crews were forced to withdraw from the building. The incident was managed from a defensive operational mode. It took crews approximately 6 hours to bring the fire under control.

The building, which was constructed in 1922 as an Armory, housed the Aberdeen Museum of History, Coastal Community Action Program and the Grays Harbor Genealogical Society was a total loss. Although, many of the artifacts that were located in the lower level of the building have been able to be preserved.

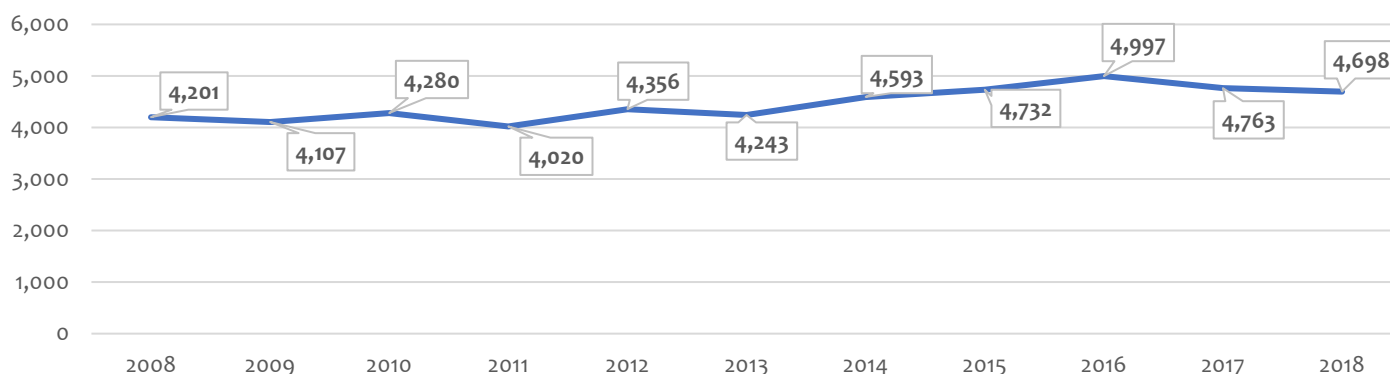
# EMERGENCY MEDICAL SERVICES

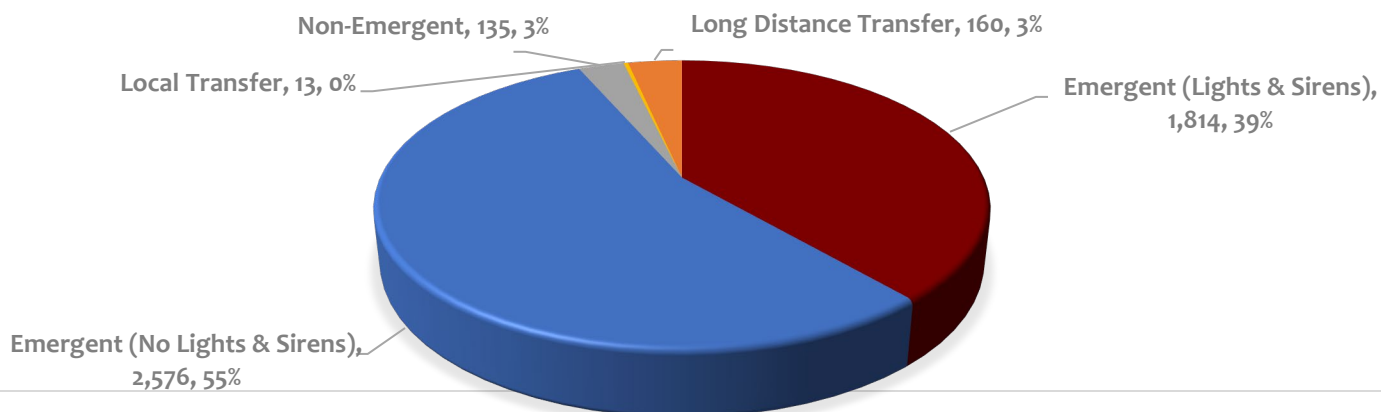
The Aberdeen Fire Department is responsible for providing emergency medical care to the citizens of the City of Aberdeen. We also provide emergency medical transport to the areas of Cosmopolis, Grays Harbor Fire District 10, Grays Harbor Fire District 15, Stafford Creek Corrections Center and other unincorporated areas outside of the city limits. The graph below illustrates the Aberdeen Fire Department's emergency medical call volume over the past ten years.

EMS CALL VOLUME: 2008-2018



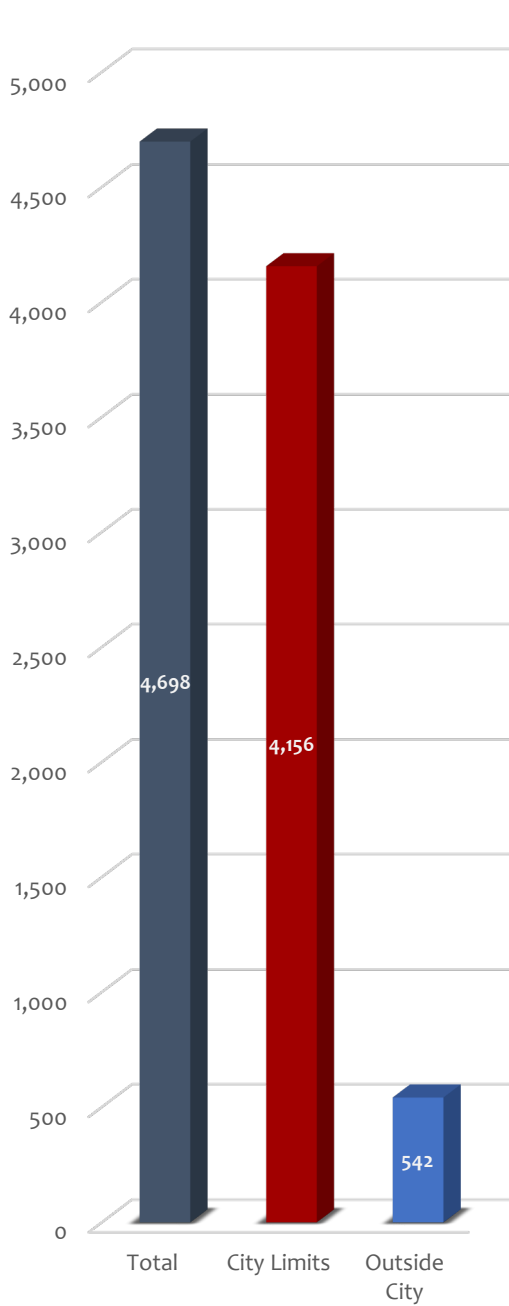
The overall EMS call volume has increased 11.8% over the past 10 years. There was a decrease in the EMS call volume from 2017 by 80 incidents. This results in a decrease of 1.7% from last year.

EMS RESPONSE BY TYPE: 2018

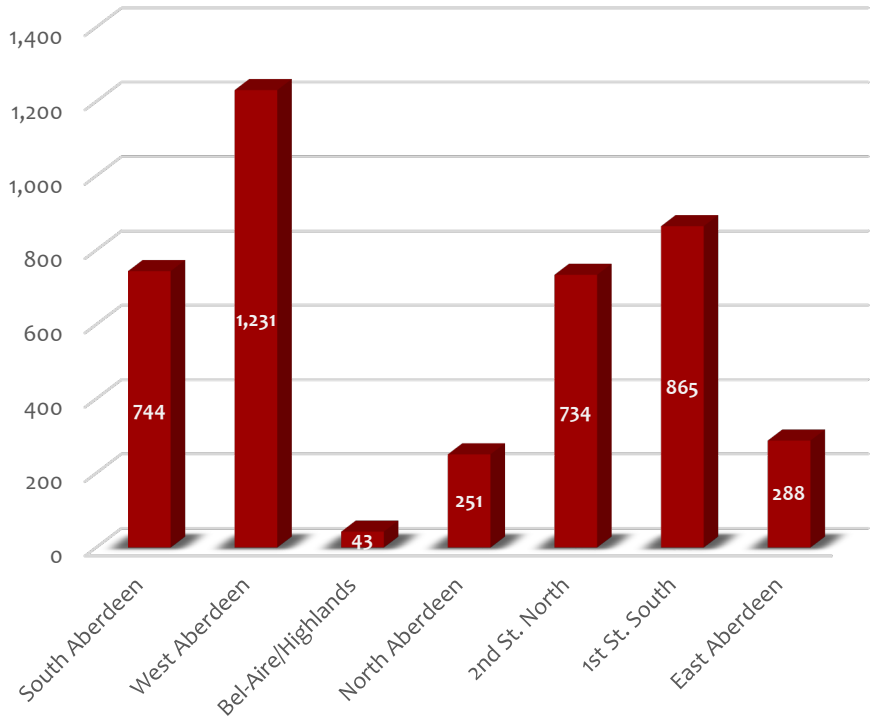




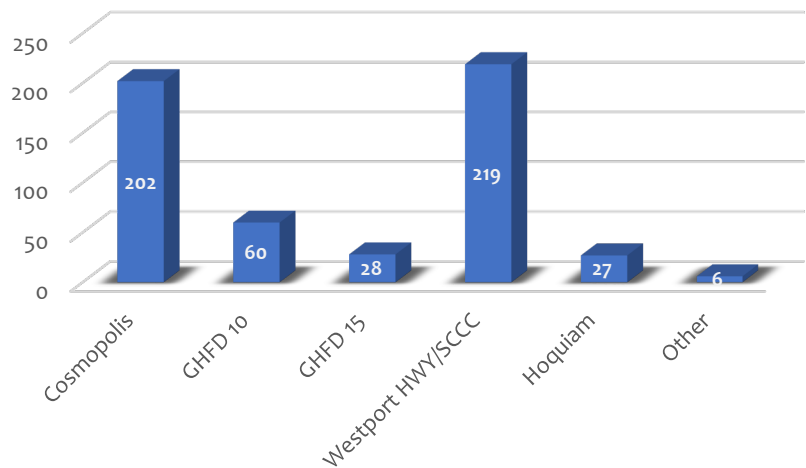

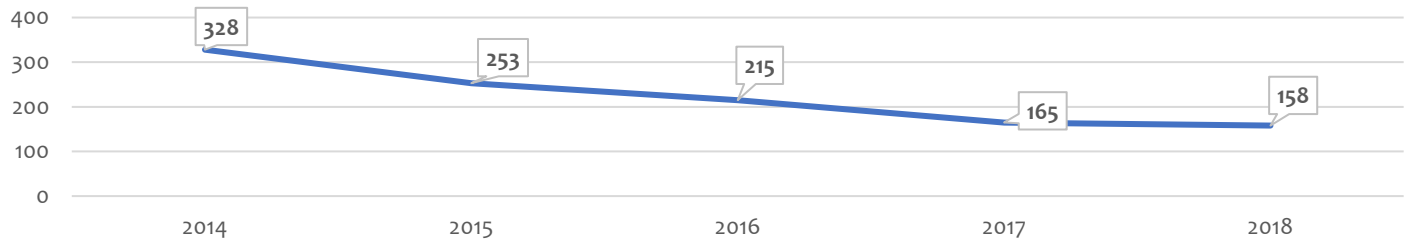
ALS: Chest Pain, Shortness of Breath, Cardiac Arrest, Unconsciousness, Blood Sugar Conditions, and severe trauma calls.

BLS: Falls, Cuts, Stomach Pain, Fever, Fainting, Swelling, and Bone Fractures.

## INTERFACILITY TRANSPORTS

The Aberdeen Fire Department will transport patients from local hospitals to other facilities out of the area for advanced care not available locally. In 2018 the Department received 554 requests for interfacility transports. The Department was able to accommodate 158 of these requests.

INTERFACILITY TRANSPORTS: 2014-2018

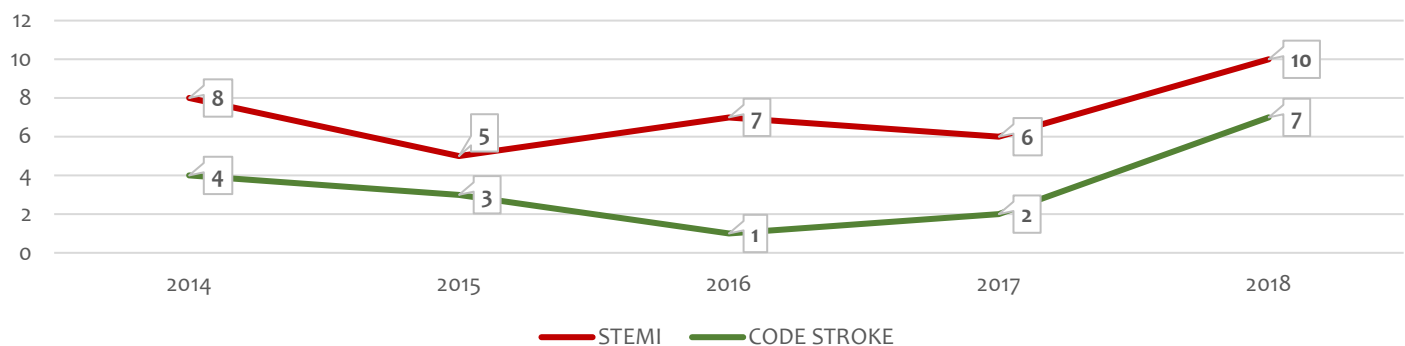


## STEMI/CODE STROKE TRANSPORTS

The Emergency Cardiac and Stroke (ECS) System was created in 2010 by the State of Washington. This system is intended to save lives and reduce disability for heart attack (STEMI), cardiac arrest and stroke patients. The Aberdeen Fire Department participates in this system by transporting patients who are in need of emergent cardiac catheterization and stroke care to out of town hospitals who specialize in these treatments.

The department utilizes on-duty staff to facilitate these transports and back-fill their positions with mandatory recall off-duty personnel. This system provides these patients with the immediate advanced medical care they need which greatly improves their chance of survival.

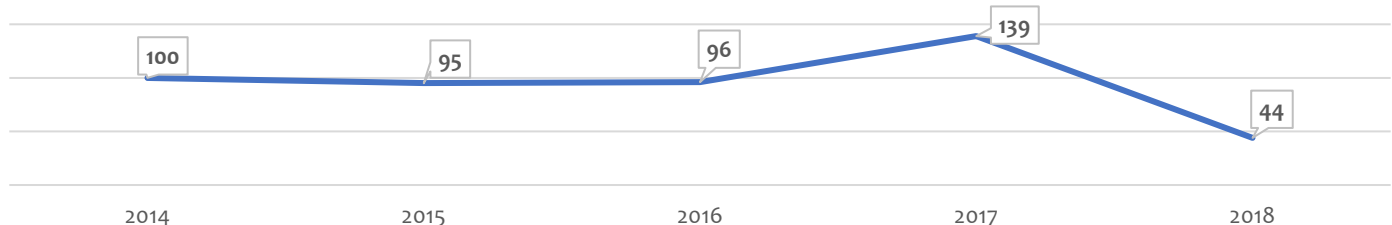
STEMI/CODE STROKE Transports: 2014-2018



## MEDICAL SAVES

During the past year the Aberdeen Fire Department documented 44 medical saves. We qualify a patient as a medical save if the patient arrives alive at Grays Harbor Community Hospital and the patient's condition most likely would have resulted in their death in the field had our crews not intervened. 2018 numbers are lower due to a change in reporting software mid-year impacting data collection. This gap has been remedied for 2019.

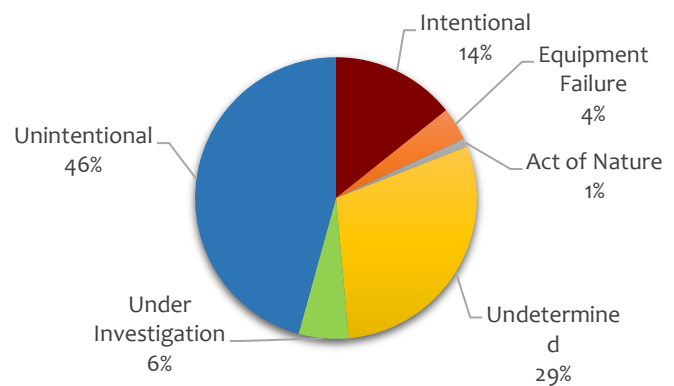
## FIRE LOSS

2018 was a year with an undetermined fire loss. The complete and total loss to the Armory Building which held the offices for Coastal Community Action Program, the Senior Center and the Aberdeen Museum of History is yet to be determined. The estimated dollar loss is several million for the structure and contents.

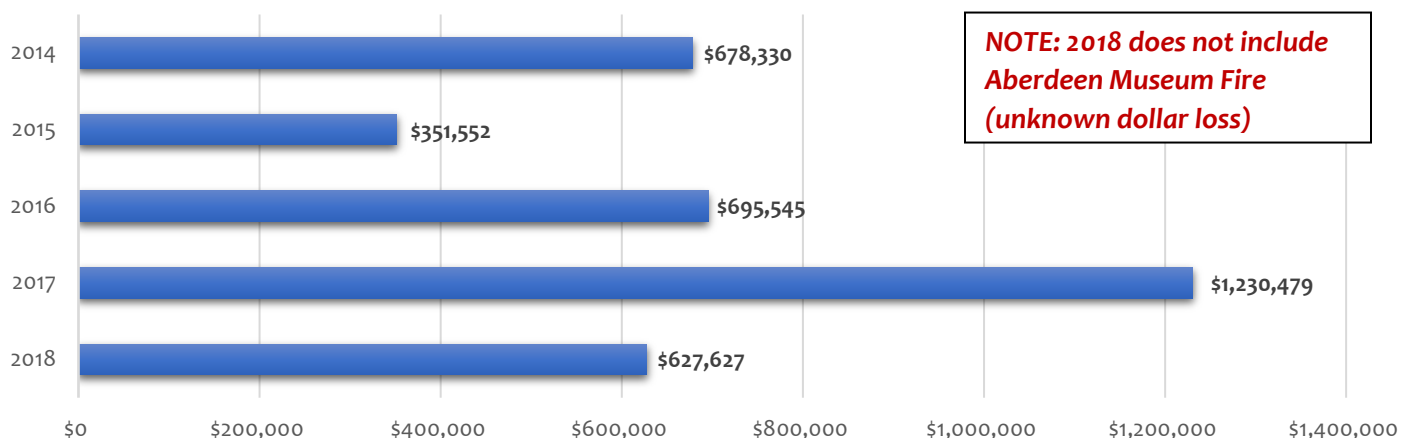
Fire Loss without the Armory Building is represented as \$627,627. This represents a decrease when compared to \$1,230,479 in 2017. The value of property saved in these events represents \$1,980,769. This fire loss represents 101 fires with significant damage to residential/ commercial property, motor vehicles, recreation vehicles, dumpsters or uncontrolled outdoor burning.

All fires in our community are investigated by the fire department. Many causes of fires are determined by a simple interview or an obvious situation caused the fire. Formal investigations are implemented when the cause or origin is not readily apparent. Last year we documented 105 investigations for cause and origin of the fires.

## FIRE CAUSE OF IGNITION: 2018



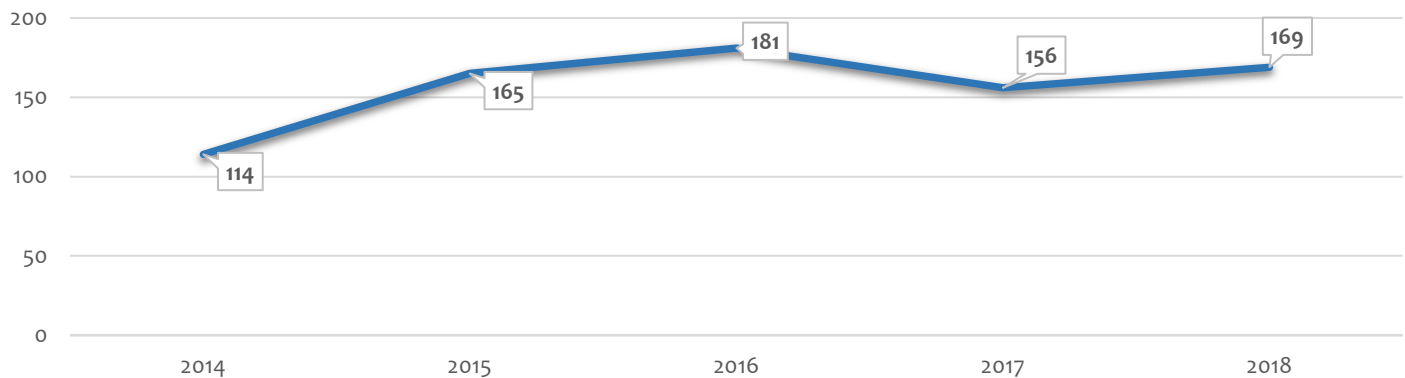
## FIRE LOSS (In Dollars): 2014-2018





Commercial business inspections are done throughout the community in compliance with the Washington Survey and Rating Bureau and requirements of the International Fire Code. Each shift at the Fire Department is assigned approximately 60 business inspections to complete during the year. Approximately 166 inspections were completed in 2018.

### PLAN REVIEW

The Fire Marshal works with the Planning and Building Departments of the City of Aberdeen. Plan Review comments on new developments and submitted building permits. Requirements for compliance with the International Fire Code are identified in this process. Plan review is followed with final inspections, which is done during and near completion of a project. The final inspections confirm that public safety components are installed and working as the plans intended.

A Certificate of Occupancy may be issued after the permit process is completed and the permits are signed, meeting the compliance of the International Fire Code, NFPA and other building code requirements.

### SMARTGOV

The Aberdeen Fire Department training program is designed to meet the mandated training requirements set forth by the State of Washington Administrative Code (WSRB), Washington State Insurance Rating Bureau, and Washington State Department of Health.

Department training is classified into several different categories:

1. Administrative – This training focuses on department organization, policies, procedures, and executive management.
2. Apparatus – Training specific to operating firefighting vehicles.
3. Driver – Training related to driving emergency response vehicles.
4. EMS – Training related to Emergency Medical Services.
5. Fire – Training focused on fire ground operations.
6. Haz-Mat – Training that covers responding to incidents that involve Hazardous Materials.
7. Leadership – Training focused on leadership development.
8. PPE – This includes training related to firefighter Personal Protective Equipment including Self Contained Breathing Apparatus.
9. Rescue – Topics related to rescue situations, such as auto extrication, elevator rescue, water rescue.
10. Safety – General safety related training.

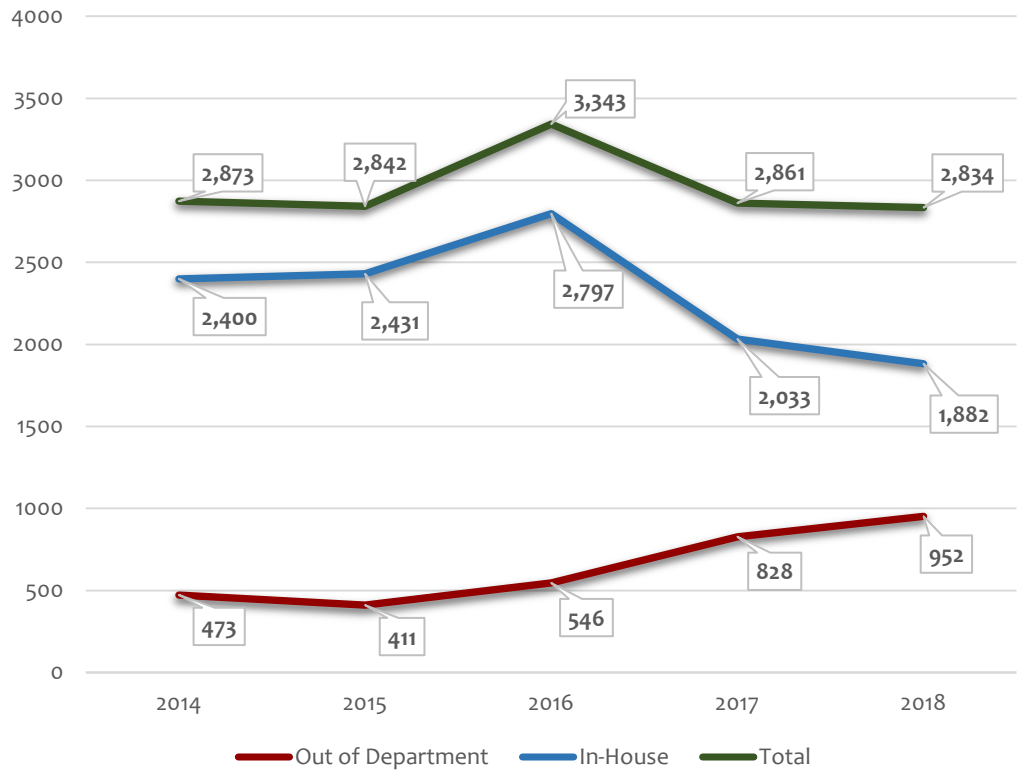

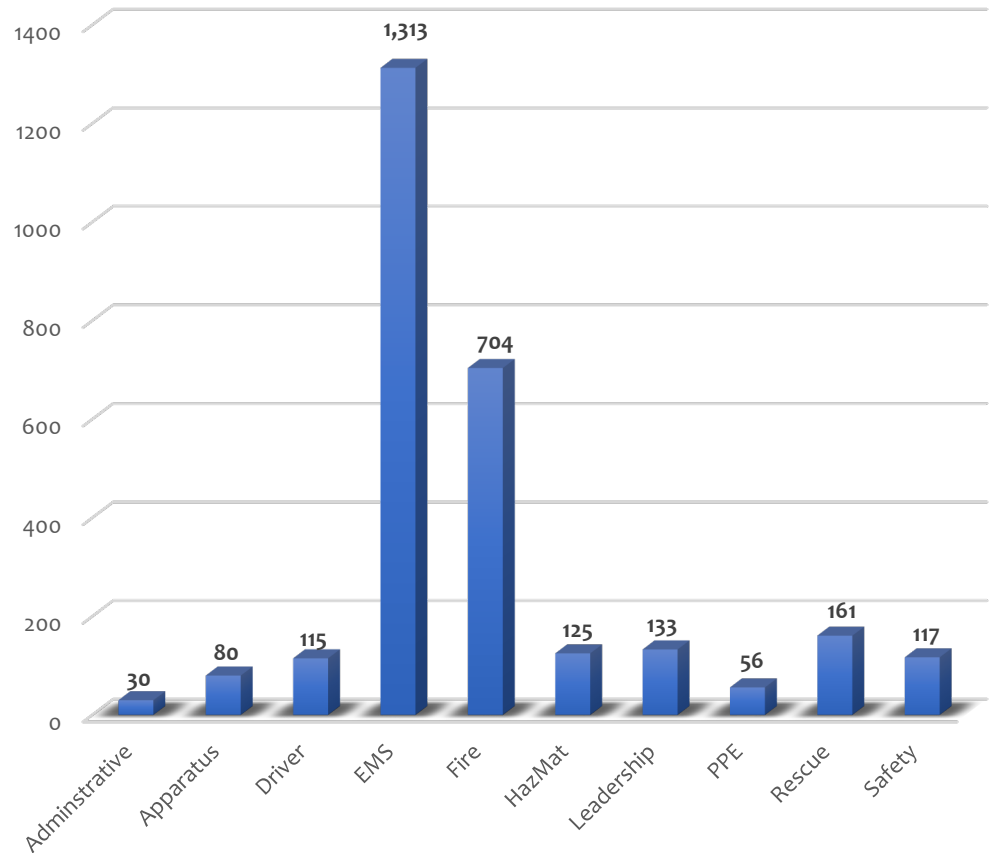

# SAFETY & HEALTH PROGRAM

The Aberdeen Fire Department Safety Committee uses continuous improvement processes to work towards eliminating the number and severity of injuries and illnesses to fire personnel during routine operations, training and emergency response. The Safety Committee utilizes safety and situational awareness, training, standard operating procedures, and implementing procedures and lessons learned through accident investigation.

Members of the Safety Committee include Battalion Chief Damon Lillybridge (Department Health and Safety Officer), Firefighter Trevor Wheeler, Firefighter Brian Newbill and Assistant Fire Chief Rich Malizia.

In 2018, the Department Safety Officer processed 14 injury reports involving department personnel. Both the injuries and exposures resulted in 2 shifts of missed work. Examples of injuries include back sprain/strain from lifting and moving patients, ankle injuries during fire overhaul, knee injuries during fire scene operations, and bloodborne exposures on EMS scenes.

Firefighters respond to incidents in all types of environmental conditions at any time of the day or night. Personal protective clothing and continuous training minimizes the risks of a firefighter being injured on the job; however, firefighting and EMS duties are often high hazard tasks with the potential for injury or exposure.

I would like to take this opportunity to commend all personnel for their efforts and participation in helping to maintain an effective and progressive safety program throughout 2018. It goes without saying that training and safety are considered two of the most important aspects of our profession. It takes the cooperation and participation of all individuals involved to make the goals and objectives, established through training and safety, relevant to our Department needs, as well as the needs of our community.

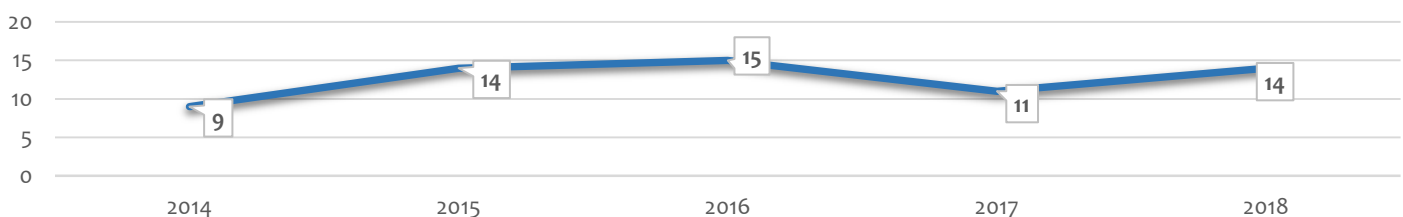

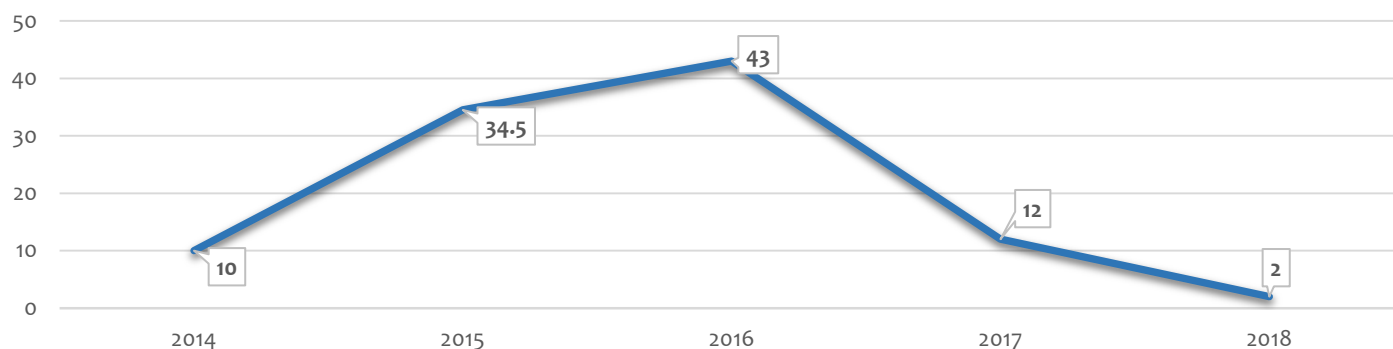

In 2018 the City of Aberdeen Fire Department Public Education Division continued to provide fire and injury prevention programs for our residents and those who attend both public and private schools in Aberdeen. The education of the citizens of Aberdeen about potential fire and life safety hazards and how to take action to avoid such hazards is extremely important. Our education efforts are intended to target all ages from early childhood to adults.

During National Fire Prevention Week firefighters visit all of the grade schools in Aberdeen. While at the elementary schools, children from kindergarten through third grade are taught about fire safety, home escape plans, smoke detectors, disaster awareness, injury prevention, just to name a few. This year the Public Education team was able to promote fire and life safety to approximately 1,300 grade school students in Aberdeen.
