Motion by Hoder, Mills to approve the minutes of the previous meeting. Carried.

Added to agenda: 1 Report from Finance and 1 Report from Public Safety.

Motion by Schave, Gordon recommending approval and payment of accounts payable in the total amount of \$215,663.87 and payroll in the total amount of \$1,439,046.78 check numbers 36142 – 36336. Roll Call: all yeas. Carried.

Report from Finance and Building Official recommending that the janitorial services contract for the City Hall building for year 2013 be awarded to McMichael Cleaning. Motion to adopt. Schave, Gordon. Carried.
